WHEREAS, I, LOUISE D. *SMITH*

(hereinafter referred to as Mortgagor) is well and truly indebted unto MOTOR CONTRACT COMPANY its successors and assigns forever (hereinafter referred to as Mortgagee) as evidenced by OF GREENVILLE, INC. the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of FIVE THOUSAND FOUR HUNDRED AND NO/100 Dollars (\$ 5400.00) due and payable

in monthly installments of \$ 90.00, the first installment becoming due and payable on the 2ND day of JULY, 1977 and a like installment becoming due and payable on the same day of each successive month thereafter until the entire indebtedness has been paid, with interest thereon from maturity at the rate of seven per centum per annum, to be paid on demand.

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, to wit:

ALL THAT CERTAIN LOT LOCATED NEAR CONESTEE, IN GANTT TOWNSHIP, GREENVILLE COUNTY, STATE OF SOUTH CAROLINA, SCHOOL DISTRICT 155, BEING KNOWN AND DESIGNATED AS LOT, No. 6, ON SPRING STREET, ADJOINING PROPERTY NOW OR FORMERLY BELONGING TO LEONARD BUSH AND H.
