(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of FIFTY FIVE THOUSAND AND NO/100 DOLLARS

(\$ 55,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

\*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 113 on a plat of STRATFORD FOREST, made by Piedmont Engineering Service, dated February 25, 1957, recorded in the RMC Office for Greenville County, S. C., in Plat Book KK at page 89, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of North Warwick Road at the joint front corner of Lots Nos. 112 and 113; and running thence with the common line of said lots, S. 77-06 W., 200 feet to an iron pin; thence along the common line of Lots Nos. 113 and 115, N. 7-37 W., 239.9 feet to an iron pin; thence along the common line of Lots Nos. 113 and 114, N. 89-34 E., 200 feet to an iron pin on the western side of North Warwick Road; thence with the curve of the western side of North Warwick Road, the chords of which are S. 4-42 W., 60 feet and S. 13-01 E., 139.5 feet to an iron pin, the point of BEGINNING.

The above described property is the same conveyed to the mortgagors herein by deed of Freda M. O'Loughlin recorded in Deed Book 1039 at page 113 on July 2, 1976.
