All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Ayrshire Drive, and being known and designated as Lot No. 5 as shown on a Plat of Spring Forest, Section II, recorded in the RMC Office for Greenville County, in Plat Book BBB, at Page 34 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at a point on the northern side of Ayrshire Drive, at the joint front corner of Lots 5 and 6; thence with the common line of said Lots N.46-06 W. 169.5 feet to a point; thence running N.68-40 E. 174.6 feet to a point at the joint rear corner of Lots 4 and 5; thence with the common line of said Lots S.30-45 E. 112.8 feet to a point on the northern side of Ayrshire Drive; thence with the line of said Drive S.53-01 W. 65 feet to a point, and S.45-51 W. 65 feet to the point of beginning.
