I, JOHN D. MULLEN----- (hereinafter referred to as Mortgagor) SENDS GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of THIRTY-NINE THOUSAND FOUR HUNDRED AND NO/100----- DOLLARS

(\$ 39,400.00-----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is # 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

Beginning at a point on the north side of Mountain View Avenue 250 feet from the northwestern corner of Mountain View Avenue and Townes Street, said point being 1 inch east of the west edge of a stone pier, thence, along the north side of the said Mountain View Avenue S. 80° 20" E. 75 feet to an iron pipe; thence, N. 9° 43" E. 222.7 feet to a point on the south side of a 10 foot alley or street (iron pin set back 15 feet from the south edge of the alley for a distance of 107.7 feet from the northern side of Mountain View Avenue), thence, along the south side of said alley or street N. 72° 54" W. 75.7 feet to a point; thence, S. 9° 43" W. 15 feet to an iron pipe; thence, continuing in the same direction S. 9° 43" W. 217.5 feet to the point of beginning. All this is in accordance with a survey made by R. A. Dalton, Engineer, January 1925.

This being the same property conveyed to the Mortgagor herein by deed of B. L. FREEMAN, JR., bearing even date herewith and recorded in the R.H.C. Office for Greenville, South Carolina.

In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the mortgagor promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraised
