 Joseph F. Charlow, Jr. and Elvira A. Charlow (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certain piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 26 on plat of Devenger Place, Section 1, recorded in Plat Book 4X at page 79 and having the following courses and distances:

BEGINNING at an iron pin on Devenger Place at the joint front corner of Lots 25 and 26 and running thence N. 48-18 W. 150 feet to an iron pin; thence along the rear of Lot 26, S. 41-42 W. 24.6 feet to a point; thence S. 2-36 W. 110.2 feet to an iron pin; thence S. 48-18 E. 80.5 feet to a point on Devenger Place; thence along Devenger Place, N. 41-42 W. 110 feet to the point of beginning.

ALSO: All that triangular piece, parcel or lot of land adjoining Lot 26 described as follows: BEGINNING at an iron pin on the northwestern side of Devenger Place at the joint front corner of Lot 26 and running thence with line of Lot 26, N. 48-18 W. 80.5 feet to an iron pin in line of Hudson Property; thence with Hudson Property, S. 2-36 W. to a point where said line intersects with the right of way of Devenger Place; with the northwestern right of way of Devenger Place in a southeasterly direction to the beginning corner.
