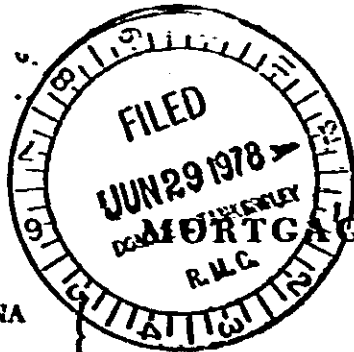

(hereinafter referred to as Mortgagee) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty Five Thousand and no/100----- ⁹⁸⁷² DOLLARS (\$ 35,000.00), with interest thereon at the rate of Six & three-fourths per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 20 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southwest side of Bartrom Grove Road, Gantt Township, being shown and designated as Lot 111 on a plat of Section II of Chanticleer, recorded in Plat Book JJJ at page 71, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Bartrom Grove Road at the joint corner of Lots 110 and 111 and running thence with the line of Lot 110, S. 38-33 W. 171.9 feet to a pin; thence S. 51-55 W. 120 feet to a pin at the corner of Lot 112; thence with the line of Lot 112, N. 38-33 E. 120.5 feet to a pin on Bartrom Grove; thence with the Southwestern side of said Street, N. 51-22 W. 120 feet to the point of beginning.
