All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeasterly side of Pine Grove Road, being shown and designated as a major portion of Lot 33 on a Plat of PINE GROVE HEIGHTS EXTENTION, recorded in the R. M. C. Office for Greenville County in Plat Book 55, at Page 83, and having, according to said Plat, the following metes and bounds:

BEGINNING at an iron pin on the northeasterly side of Pine Grove Road, joint front corner of Lots 32 and 33, and running thence N 36-23 E, 151.2 feet to a point; thence S 02-25 E, 200 feet to an iron pin on the northeasterly side of Pine Grove Road; thence with the northeasterly side of said Road, N 48-10 W, 87.9 feet to an iron pin; thence still with said Road, N 59-35 W, 38 feet to the point of beginning.
