NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

State of South Carolina, known and designated as Lot No. 171 on plat of Colonial Hills, Section 4, prepared by Piedmont Engineers and Architects, dated October 26, 1967, and recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book WW at page 3, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Heathwood Drive, at the joint front corner of Lot Nos. 171 and 172, and running thence N. 0-33. E. 185.8 feet to an iron pin; thence S. 86-50 E. 69.5 feet to an iron pin; thence S. 9-25 E. 163.8 feet to an iron pin on Heathwood Drive, at the joint front corner of Lot Nos. 170 and 171; thence along Heathwood Drive S. 78-20 W. 100 feet to an iron pin, the point of beginning.
