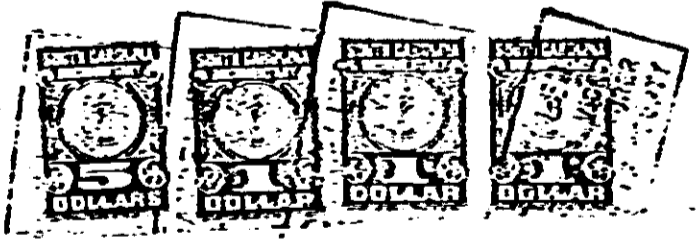

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Paris Mountain Township, lying on the Eastern side of Hiwassee Drive being known and designated as Lot No. 53 of a subdivision known as Indian Hills as shown on a plat thereof being recorded in the RMC Office for Greenville County in Plat Book QQ, at Page 11, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Western side of Hiwassee Drive, joint front corner of Lots Nos. 52 and 53, and running thence with joint line of said lots S. 80-30 W. 180 feet to iron pin in line of Lot No. 57; thence with said lot N. 9-30 W. 44.9 feet to iron pin at corner of Lot No. 55; thence with line of Lot No. 55, N. 41-30 E. 88.4 feet to an iron pin at corner of Lot No. 54; thence with line of Lot No. 54, N. 80-30 E. 111.2 feet to iron pin on Western side of Hiwassee Drive; thence with said Drive S. 9-30 E. 100 feet to the beginning corner.
