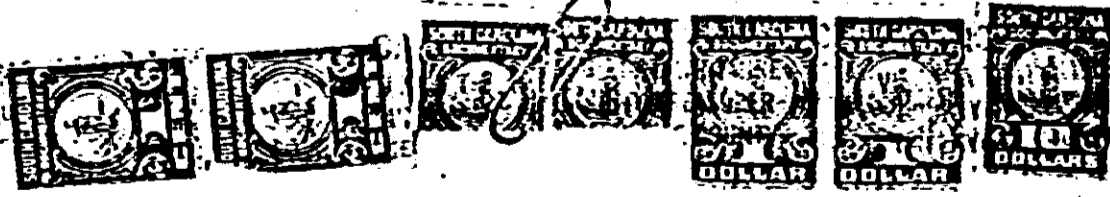

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 37, Mountainbrooke Subdivision, Plat of which is recorded in the RMC Office for Greenville County in Plat Book 4-F, at Page 47, and having, according to said plat, the following metes and bounds:

Beginning at an iron pin on the southeastern side of Crosscreek Lane at the joint front corner of Lots 36 and 37, and running thence along the common line of said Lots, S 48-00-50 E, 165 feet to an iron pin; thence N 43-18-00 E, 164.61 feet to an iron pin; thence N 74-37-40 W, 188.7 feet to an iron pin on Crosscreek Lane; thence S 41-59-10 W, 80 feet to the point of beginning.
