THIS MORTGAGE made this 24th day of August, 19 78,
among Louis F. Snedigar & Vicki M. Snedigar (hereinafter referred to as Mortgagor) and FIRST
UNION MORTGAGE CORPORATION, a North Carolina Corporation (hereinafter referred to as Mortgagee):

WITNESSETH THAT, WHEREAS, Mortgagor is indebted to Mortgagee for money loaned for which
Mortgagor has executed and delivered to Mortgagee a Note of even date herewith in the principal sum of
Ten Thousand and No/100----- (\$ 10,000.00), the final payment of which
is due on September 15 19 88, together with interest thereon as
provided in said Note, the complete provisions whereof are incorporated herein by reference;

AND WHEREAS, to induce the making of said loan, Mortgagor has agreed to secure said debt and interest
thereon (together with any future advances) and to secure the performance of the undertakings prescribed in the
Note and this Mortgage by the conveyance of the premises hereinafter described:

NOW, THEREFORE, in consideration of the aforesaid loan and the sum of Three Dollars (\$3.00) cash in
hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, convey,
assigns and releases to Mortgagee, its successors and assigns, the following described premises located in
Greenville County, South Carolina:

ALL that certain piece, parcel or lot of land situate, lying and being
in the State of South Carolina, County of Greenville, being known and
designated as Lot No. 71 of a subdivision known as Pebble Creek, Phase I
as shown on a plat thereof prepared by Enwright Associates, Engineers,
dated October, 1973, recorded in the RMC Office for Greenville County
in Plat Book 5-D at Pages 1-5, and having, according to said plat, the
following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Sassafras Drive at
the joint front corner of Lots 70 and 71 and running thence with the joint
line of said Lots, N. 35-18 W. 204.36 feet to an iron pin in the line of
Duke Power Co. right of way; thence with the line of said right of way,
N. 52-56 E. 60 feet to an iron pin at the joint rear corner of Lots 71
and 72; thence with the joint line of said Lots, S. 58-48 E. 86.95 feet
to an iron pin on the northwestern side of Sassafras Drive; thence with
Sassafras Drive, following the curvatures thereof, the chords of which
