All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 90 on plat of Park Hill, revised by Dalton and Neves, Engineers, May, 1940, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book J at Pages 208 and 209, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Northwest corner of the intersection of Aberdeen and Melville Avenue, and running thence with the North side of Aberdeen Drive, N. 69-38 W. 60.9 feet to an iron pin on said drive at joint front corner of Lots Nos. 90 and 91; thence with the line of Lot No. 91, N. 25-56 E. 157.5 feet to an iron pin in the line of Lot No. 89; thence with the line of Lot No. 89, S. 61-17 E. 86.4 feet to an iron pin on the West side of Melville Avenue; thence with the West side of Melville Avenue, S. 35-57 W. 150 feet to the beginning corner.
