WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Ten Thousand and no/100-----DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated

as lot no. 14 according to a plat of Property of the Estate of J. Rowley Yown, plat recorded in the R.M.C. Office for County and State aforesaid in Plat Book J at pages 258 and 259 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the eastern side of new cut Dunham Bridge Road at the joint western corner of lots 14 and 15 and running thence along the dividing line of said lots S. 74-04 E. 374.4 feet to an iron pin on the western side of Welcome Road; thence along Welcome Road S. 30-52 E. 88.1 feet to an iron pin; thence S. 15-56 W. 39 feet to joint rear corner of lots 14 and 13; thence N. 74-04 W. 440 feet to joint front corner of lots 14 and 13 fronting on new cut Dunham Bridge Road; thence N. 15-56 E. 100 feet to the point of beginning.
