"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as Lot 58 as shown on plat of Sherwood Forest, recorded in Plat Book Y at Pages 30-31 in the RMC Office for Greenville County, and being more particularly described according to said plat as follows:

BEGINNING at an iron pin on the Western side of Legrand Boulevard joint front corner of Lots 58 and 59, and running thence with the joint line of said lots, S. 68-49 W. 150 feet to an iron pin; thence N. 21-11 W, 70 feet to an iron pin, rear corner of lot 57; thence with the line of said lot, N. 68-49 E. 150 feet to an iron pin in the West side of Legrand Boulevard; thence with said Boulevard, S. 21-11 E. 70 feet to the point of beginning.
