WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Thirty-Six Thousand Three Hundred and 00/100**-----DOLLARS

(\$ 36,300.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is **30** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 180 of a subdivision known as Botany Woods, Sector IV, and shown on a plat thereof, said plat being recorded in the R.M.C. Office for Greenville County in Plat Book YY-23, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Bridgewater Drive at the joint front corner of Lots 180 & 181, and running thence with the southern side of Bridgewater Drive N. 41-41 W. 35 feet to an iron pin; thence continuing with the southern side of Bridgewater Drive N. 52-05 W. 47.8 feet to an iron pin; thence continuing with the southern side of Bridgewater Drive N. 53-27 W. 77.2 feet to an iron pin at the joint front corner of Lots 179 & 180; thence with the joint line of said Lots S. 36-33 W. 153 feet to an iron pin; thence with the rear line of Lot 180 S. 56-50 E. 106.9 feet to an iron pin at the joint rear corner of Lots 180 & 181; thence with the joint line of said Lots N. 57-43 E. 147.7 feet to the point of beginning.
