Forty-One Thousand Six Hundred and No/100-----DOLLARS

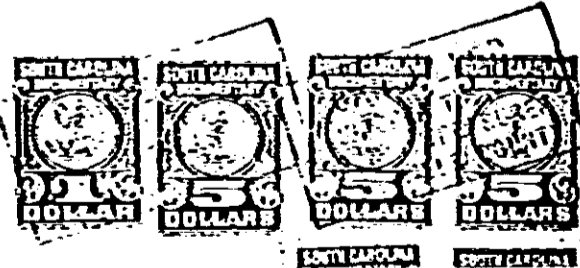

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 42 on plat of Edwards Forest Heights as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 000, at Page 89, and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at an iron pin on the southern edge of Oakleaf Drive, joint front corner of Lots Nos. 43 and 42, and running thence with the southern edge of said Drive, N. 88-31 E. 110 feet to an iron pin; thence with the common line of Lots Nos. 42 and 41, S. 1-41 E. 214.4 feet to an iron pin; thence, N. 65-30 W. 123.6 feet to an iron pin, joint rear corner of Lots Nos. 42 and 43; thence with the common line of said lots, N. 1-29 W. 160 feet to an iron pin, the point of beginning.
