Merry (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of -----  
Thirty Thousand Five Hundred and No/100 (\$30,500.00)----- DOLLARS

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the southern side of West Earle Street, and being known as Lot N, on Map 5 of Mountain City Land and Improvement Co., and also being known as 209 West Earle Street, and having the following metes and bounds, to-wit:
