All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwest side of Augusta Road, being shown as a portion of Lot No. 2 on Plat of Property of G. F. Cammer, made by R. E. Dalton, Engineer, February, 1923, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "L", at page 115, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwest side of Augusta Road at joint front corner of Lots Nos. 1 and 2 and running thence along the southwest side of Augusta Road S. 36-48 E. 89 feet to an iron pin at corner of Augusta Road and Cammer Avenue; thence along the northwest edge of Cammer Avenue S. 44-17 W. 183.1 feet to an iron pin at the corner of Lot of John M. Parker; thence along the Parker line N. 47-24 W. 87.9 feet to an iron pin in joint line of Lots Nos. 1 and 2; thence along the line of Lot No. 1 N. 44-17 E. 185 feet, more or less, to an iron pin on the southwest side of Augusta Road, the beginning corner.
