WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of TWENTY-ONE THOUSAND FIVE HUNDRED FIFTY AND NO/100-----DOLLARS

ALL that certain piece, parcel or lot of land with improvements thereon, situate on the northwestern side of Perrin Street, in the City of Greenville, South Carolina, and shown as Lot No. 7 on a plat of property of E. R. Griffin, made by Dalton and Neves, Engineers August, 1951, recorded in the RMC Office for Greenville County in Plat Book "AA" at page 185, and having according to said plat the following metes and bounds, to-wit:
