 (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southwestern corner of Shelburne Road and Sagamore Lane, being shown and designated as Lot 203 on plat of Section B of Gower Estates recorded in Plat Book XX at pages 36 and 37 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Shelburne Road at the joint corner of Lots 202 and 203 and running thence with the line of Lot 202, S. 2-35 W. 175 feet to pin; thence S. 87-25 E. 125 feet to pin on Sagamore Lane; thence with the western side of Sagamore Lane, N. 2-35 E. 150 feet to pin at corner of Shelburne Road; thence with the curve of the intersection of Sagamore Lane and Shelburne Road, N. 42-35 W. 35.4 feet to pin on Shelburne Road; thence with the southern side of said Road, N. 87-35 W. 100 feet to the beginning corner.
