WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as LOT 115, Section 1 C, Westcliff Subdivision as shown on plat prepared by Piedmont Engineering Service on December 11, 1963 and revised September 24, 1965 and recorded in the RMC Office for Greenville County in Plat Book JJJ, at pages 72 through 75 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northwestern side of Willenhall Lane at the joint front corner of Lots 115 and 116 and running thence North 14-23 West 286.5 feet to an iron pin; running thence South 68-56 East 265 feet to an iron pin; running thence South 28-01 West 40.2 feet to an iron pin on the Northwestern side of Willenhall Lane; running thence with Willenhall Lane, South 64-04 West 89 feet to an iron pin; thence continuing with Willenhall Lane, South 57-00 West 36 feet to the point of beginning.
