TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, J. E. Meadors (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of --Thirty-Four Thousand Five Hundred and No/100-- DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Chick Springs Township, being shown and designated as lot No. 295 of Sector VI on plat of BOTANY WOODS, recorded in Plat Book YY at Page 131, and having according to said plat the following metes and bounds, to-wit:
