WHEREAS, the Mortgagor is well and truly indebted unto

Fidelity Federal Savings & Loan Association, a corporation organized and existing under the laws of the United States of America, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Nine Thousand Nine Hundred Fifty & No/100 Dollars (\$ 9950.00), with interest from date at the rate of four & One-half per centum (4½ %) per annum until paid, said principal and interest being payable at the office of

Edwards, recorded in Plat Book S at Page 12, and having according to said plat the following metes and bounds, to-wit:
