(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

----- Four Thousand and No/100 ----- DOLLARS
(\$ 4,000.00), with interest thereon at the rate of six & one-half per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 10 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Otis Street, in the City of Greenville, shown as Lot 206 on plat entitled "Mills Mill", recorded in Plat Book GG at Pages 60-61 in the R.M.C. Office for Greenville County, and described as follows:

"BEGINNING at an iron pin on the southern side of Otis Street, at the joint front corner of Lots 205 and 206, and running thence with line of Lot 205 N. 30-12 W. 157.5 feet to iron pin; thence S. 60-43 W. 80.1 feet to iron pin at the rear corner of Lot 207; thence with line of Lot 207, N. 30-12 W. 156.4 feet to iron pin on the southern side of Otis Street; thence with the southern side of Otis Street N. 59-48 E. 80 feet to the beginning corner."
