"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being shown as Lot #29 on plat of Section II of Spring Forest, recorded in the R.M.C. Office for Greenville County in Plat Book "BBB" at page 34, being described as follows:
