One Hundred (\$100.00) Dollars per month beginning August 1, 1975 and each month thereafter until Forty-Five Hundred (\$4,500.00) Dollars in principal and interest are paid.

with interest thereon from date at the rate of 6% per centum per annum, to be paid: in each payment.

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville.

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, and more particular described as follows and recorded in Plat Book E, page 249, in the R. M. C. Office for Greenville County and having the following metes and bounds:

BEGINNING at an iron pin which is located 50.95 feet from the corner of Valley and Goodrich Streets and running thence S. 64-49 E. 50.95 feet along Goodrich Street; thence N. 36-15 E. 169.5 feet to an iron pin; thence N. 53-45 W. 50.24 feet to an iron pin; thence N. 36-15 E. 174.4 feet to an iron pin, joint corner of lots 74 and 75; thence along Goodrich Street S. 64-49 E. 50.95 feet to the point of beginning.
