(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of SIXTEEN THOUSAND NINE HUNDRED FIFTY AND NO/100

(\$ 16,950.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of Governors Square, being shown and designated as Lot No. 18, as shown on a plat of Governors Square prepared by S. R. Williams, Jr., Engineer/ Surveyor, dated October 17, 1975, recorded in the Office of the RMC for Greenville County, South Carolina, in Plat Book 5-P, at Page 8, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Governors Square at the joint front corner of Lots 17 and 18, and running thence with the common line of said two lots, N. 49-14 E. 147.6 feet to an iron pin; thence with the common line of Lots 18 and 20, N. 58-43 W. 90 feet to an iron pin (at the joint corner of Lots 18, 19, and 20; thence with the common line of Lots 18 and 19, S. 84-27 W. 101.1 feet to an iron pin on the Eastern side of Governors Square; thence with the Eastern side of Governors Square, the following courses and distances: S. 16-44 E. 50 feet to an iron pin, S. 26-12 E. 50 feet to an iron pin, S. 35-40 E. 50 feet to the point of beginning.
