TO ALL WHOM THESE PRESENTS MAY CONCERN:

Walter E. Pinson, Elizabeth J. Pinson  
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Three Thousand Two Hundred and No/100----- DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, located on the North-western intersection of Crestone Drive (formerly Kings Street) and Valley Street, being shown as the front portion of Lot #18 on plat recorded in Plat Book F, Page 140, and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin at the Northwestern corner of Crestone Drive, and Valley Street, and running thence with the Northern side of Crestone Drive, N. 46-45 W. 50 feet to an iron pin at the corner of Lot #17; thence with the line of Lot #17, N. 43-15 E. 87 feet to an iron pin; thence through Lot #18, S. 46-45 E. 50 feet to an iron pin on Valley Street; thence with Valley Street, S. 43-15 W. 87 feet to the point of beginning.
