All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Mauldin, being known and designated as Lot No. 59 as shown on a plat of Burdett Estates prepared by Dalton & Neves, Engineers, dated August 1, 1973, recorded in the RMC Office for Greenville County, S. C., in Plat Book 4-X, Page 60, and having according to said plat the following metes and bounds, to-wit:
