All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, about four miles northwest of the Greenville County Courthouse, near Berea School, on the western side of White Horse Road and being described more particularly, to-wit:

BEGINNING at a point in the western right-of-way line of White Horse Road at the joint corner of property now or formerly belonging to J. T. Burdine, Jr., and running thence along said Road S 4-00 E 100 feet to a point on said Road; thence S 81-51 W 386.5 feet to an iron pin; thence N 4-00 W 100 feet to an iron pin; thence N 81-51 E 386.5 feet to the point of beginning.
