NOW, KNOW ALL MEN that the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further debts for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, within the corporate limits of the City of Greenville, and being known and designated as Lot Number 116 of a subdivision known as Vista Hills, a plat of which is of record in the R. M. O. Office for Greenville County in Plat Book P at Page 149, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Chick Springs Road at the joint front corner of Lots 115 and 116 and running thence with the Southeastern side of Chick Springs Road N 16-54 E 75.1 feet to a point; thence continuing with the Southeastern side of Chick Springs Road N 1-25 E 40 feet to a point; thence following the curvature of the Southwestern intersection of Chick Springs Road with Wellington Avenue (the chord of which is N 71-40 E) 42.8 feet to a point; thence with the Southwestern side of Wellington Avenue S 47-01 E 118 feet to a point in an alley at the rear corner of Lot 116; thence with said alley S 6-02 W 72.8 feet to a point at the joint rear corner of Lots 115 and 116; thence N 71-20 W 131.7 feet to a point on the Southeastern side of Chick Springs Road, at the point of BEGINNING.
