WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty-eight Thousand Seven Hundred and No/100

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina on the northern side of Lanneau Drive known and designated as Lot No. 25 on plat of the Estate of John T. Jenkinson Property recorded in Plat Book H at Page 207, in the R.M.C. Office for Greenville County, South Carolina and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Lanneau Drive, the joint front corner of Lots 25 and 26 and running thence with the joint line of said lots, N. 31-22 E., 170.9 feet to an iron pin; thence S. 50-56 E., 70 feet to an iron pin at the joint rear corner of Lots Nos. 24 and 25; thence with the line of Lot No. 24, S. 32-47 W., 164.3 feet to an iron pin on the northeastern side of Lanneau Drive; thence with the northeastern side of Lanneau Drive N. 56-33 W., 65 feet to the point of beginning.
