\*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Mauldin, and shown as Lot No. 64 on a revised plat entitled Lot No. 64, Holly Springs, Section II, dated February 13, 1974, by Piedmont Engineers and Architects and recorded in the R.M.C. Office for Greenville County in Plat Book 6-G at Page 95, and having according to said plat, the following metes and bounds, to-wit:
