EDWARD J. NASSER

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Five Thousand and No/100 ----- DOLLARS

(\$ 5,000.00-----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is Seven (7) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being on the east side of Maco Terrace in the City of Greenville, being known and designated as Lot 15, according to plat made by Pickell & Pickell, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "P" at page 51, and according to said plat, the property is described as follows:

BEGINNING at a point on Maco Terrace, which is the corner of Maco Terrace and a 18-foot alley, and running thence along the eastern side of Maco Terrace N. 36-05 W. 64 feet to a point, joint corner of lots Nos. 14 and 15; thence along the joint line of said lots N. 54-03 E. 125 feet to a point at the joint rear of said lots; thence S. 36-05 E. 64 feet to a point on the above mentioned 18-foot alley which is the rear of Lot No. 15; thence along the said alley S. 54-03 W. 125 feet to the point of beginning.
