(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of THIRTY THOUSAND DOLLARS

(\$ 30,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near and east of the City of Greenville, and being known and designated as Lot Number 16 of a subdivision known as Terra Pines Estates Section 4, a plat of which is of record in the RMC Office for Greenville County in Plat Book 000 at page 85, and having the following metes and bounds, to-wit:

Beginning at a point on the northwestern side of Compton Drive at the joint corner of Lots 16 & 17 and running thence with the northwestern side of Compton Drive N. 59-55 E. 48.3 feet to a point; thence continuing with the northwestern side of Compton Drive N. 47-49 E. 88.05 feet to a point; thence still continuing with the northwestern side of Compton Drive N. 39-52 E. 139.2 feet to a point; thence following the curvature of the northwestern intersection of Compton Drive with a proposed street leading to a proposed community recreation area (the chord of which is N. 8-48 E) 42.8 feet to a point; thence with the southwestern side of said proposed street N 22-15 W 250 feet to a point at the rear corner of Lot 16; thence with the joint line of this lot and said proposed community recreation area S 60-16 W 215.5 feet to a point at the joint rear corner of Lots 16 & 17; thence S. 12-30 E. 365.8 feet to a point on the Northwestern side of Compton Drive at the point of beginning.
