WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

DOLLARS (\$9,900.00), with interest thereon from date at the rate of five and three-fourths per centum per annum, said principal and interest to be repaid in monthly instalments of Eighty-Two and No/100 - - - - - Dollars (\$82.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville on the Northern side of Sandra Avenue, being the rear portion of lot in subdivision of the property of J. Furman Clardy on White Horse Road and having according to survey made by T. C. Adams the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Sandra Avenue, which pin is 440 feet southwest from the intersection of Sandra Avenue and White Horse Road and running thence with the northwestern side of Sandra Avenue, S. 31-20 W. 150 feet to pin on 10 foot alley; thence with said alley, N. 65-15 W. 101.8 feet to pin in line of property formerly owned by Robert L. Southerland; thence with Southerland line, N. 31-20 E. 150 feet to an iron pin; thence S. 65-10 E. 101.8 feet to the point of beginning.
