All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the Southern intersection of Old Spartanburg Road and Marchant Road, being shown and designated as Lot No. 57 on a Plat of CAMBRIDGE PARK, made by Dalton & Neves, dated June 1, 1972, and recorded in the RMC Office for Greenville County, South Carolina in Plat Book 4R, Page 11 and having according to said Plat the following metes and bounds, to-wit:
