

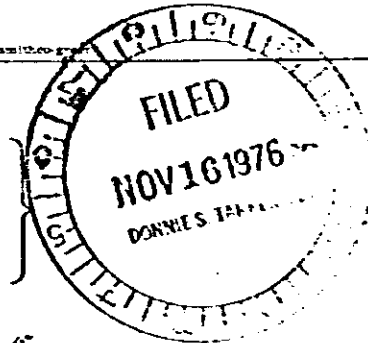

To All Whom These Presents May Concern:

I, George J. Robinson hereinafter called the Mortgagor(s), SEND GREETING:

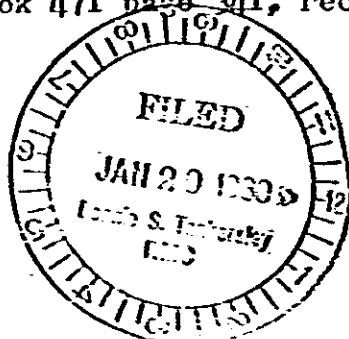
WHEREAS, the said Mortgagor(s) in and by my certain promissory note in writing, of even date with these Presents, am well and truly indebted to BANK OF GREER, GREER, S. C., hereinafter called Mortgagee, in the full and just sum of Thirty one hundred sixty five & 48/100 DOLLARS, to be paid in monthly installments of \$ 87.93, commencing on the 11 day of Dec. and on the 11 day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not paid sooner, shall be due and payable on the 11 day of NOV. 1979.

with interest thereon from date at the rate of 7 per centum per annum, to be computed and paid monthly, as stated above, until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agree(s) to pay all costs and expenses including a reasonable amount as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor(s) paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee,

All that piece, parcel or lot of land with all improvements thereon, located in said State and County, Chick Springs Township, being known and designated as Lot #46 Block "B" and lot 48 Block "B" of Pinehurst, as shown on a plat thereof recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book "S" at page 77, reference to said plat being made for a more complete and adequate description thereof. This being all of my right, title and interest in and to the same lots of land conveyed to Grantee herein and myself jointly by William C. Dempsey by deed recorded in the Office of R.M.C. for Greenville County, S.C. in Deed Book 471 page 341, recorded, Feb. 2, 1953.
