All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

And being known and designated as Lot No. 2 of the property of Shirley L. Styles as shown on Plat recorded in the R.M.C. Office for Greenville County in Plat Book L, at page 151, and being more particularly described according to said Plat as follows:

BEGINNING at an iron pin at the Northwestern intersection of Carroll Street and McPherson Street, and running thence with Carroll Street, N. 73-22 W. 72.7 feet to a stake, joint Southern corner of Lots Nos. 2 and 3; thence with the dividing lines of said lots, N. 13-46 E. 182.1 feet to an iron pin, joint Northern corner of Lots Nos. 2 and 3; thence with the rear line of Lot No. 2 S. 73-22 E. 61 feet to an iron pin on McPherson Street; thence along the line of said McPherson Street, S. 10-11 W. 183.2 feet to the beginning corner.
