TO ALL WHOM THESE PRESENTS MAY CONCERN: James W. Doares and Amy S. Doares

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty Thousand and No/100ths-----DOLLARS

(\$ 40,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Waccamaw Avenue being shown and designated on a plat of Property of James W. Doares and Amy S. Doares recorded in the RMC Office for Greenville County, South Carolina in Plat Book 5M Page 98 by Carolina Surveying Co. dated July 8, 1975 and having, according to said plat, the following rates and bounds, to-wit:

BEGINNING at a point on the eastern side of Waccamaw Avenue which point is located 90 feet from the southeastern corner of the intersection of said Waccamaw Avenue and a 20 foot alley and running thence S. 69-52 E. 227.8 feet to a point; thence S. 11-58 W. 247.6 feet to a point; thence N. 78-02 W. 225 feet to a point on the eastern side of Waccamaw Avenue; thence along the eastern side of said Waccamaw Avenue, N. 11-58 E. 280 feet to the point of beginning.
