All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of East Eighth Street, being shown and designated as Lot No. 92 on plat of Woodside Mills, Section C, dated January 14, 1950, prepared by Pickell & Pickell, RLS, recorded in Plat Book W at Pages 111 thru 117, and being described, according to said plat, more particularly,

to-wit:

BEGINNING at an iron pin on the southern side of East Eighth Street at the joint front corner of Lots 92 and 93 and running thence along the common line of said lots S. 07-29 E. 119.6 feet to an iron pin at the joint rear corner of said lots on the northern side of a 12-foot alley; thence S. 32-37 W. 66 feet to an iron pin at the joint rear corner of Lots 92 and 91; thence along the common line of said lots N. 07-29 W. 119.5 feet to an iron pin on the southern side of East Eighth Street at the joint front corner of said lots; thence along the southern side of said street N. 32-31 E. 66 feet to an iron pin, the point of beginning.
