WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty One Thousand Eight Hundred and No/100 DOLLARS

(\$41,800.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand well and truly paid by the Mortgagor at and for the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, being and lying in the State of South Carolina, County of Greenville, at the northeastern corner of the intersection of Cunningham Road with Lynn Drive, being shown and designated as Lot No. 19 on plat of Rosewood Acres, County of Greenville, said plat made by Terry T. Dill, Surveyor, dated April 22, 1960, and recorded in the REC Office for Greenville County, South Carolina in Plat Book M1, Page 154, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of Lynn Drive at the joint front corner of Lots 19 and 21, and running thence along the common line of said lots S. 3-00 E. 149 feet to an iron pin; thence along the common line of Lots 19 and 20 N. 86-19 W. 184.3 feet to an iron pin on the east side of Cunningham Road; thence along the east side of Cunningham Road N. 10-0 W. 71 feet to an iron pin; thence following the curve of Cunningham Road and Lynn Drive, the chord of which is N. 41-50 E., 39.3 feet to an iron pin on the south side of Lynn Drive; thence along the south side of Lynn Drive S. 86-21 E. 169 feet to the point of beginning.

This being the same property conveyed to the mortgagor herein by deed of Gerald R. Glur recorded in the REC Office for Greenville County, South Carolina simultaneously herewith.

In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the mortgagor promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the
