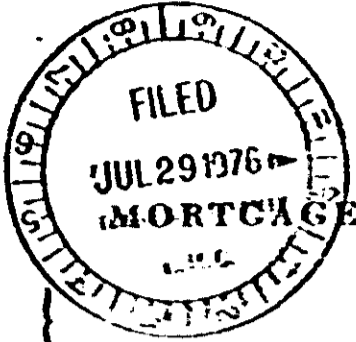

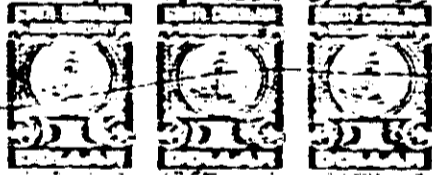

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate, lying and being on the southern side of McDaniel Court (formerly Carroll Street) 101 S. 20-29 E. 168.2 feet to Carroll Street; thence along the line of that street S. 57-94 E. 75 feet; thence S. 63 E. 75 feet along said street; thence still along said street S. 75-10 E. (sic) 120.5 feet to branch, the beginning point.
