All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville.

On the Eastern side of Flamingo Drive, near the City of Greenville, being shown as Lot 11 on a plat of Wade Hampton Gardens, recorded in Plat Book MM at page 199 and described as follows:
