MORTGAGE

THIS MORTGAGE is made this 28th day of October, 1977, between the Mortgagor, Harold O. Durham and Evelyn P. Durham, (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of ---Eight Thousand Five Hundred and NO/100--- Dollars, which indebtedness is evidenced by Borrower's note dated October 28, 1977, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on December 1st, 1982,

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of GREENVILLE State of South Carolina: III Chick Springs Township, situated on the Western side of Ashmore Street, in the City of Greer, S.C., and known and designated as all of LOT NO. 10 of the property of Geanie E. Caldwell, according to survey and plat thereof by E. L. Dunahoo, Surveyor, dated October 24, 1949, and recorded in Plat Book "X" at page 1, R.M.C. Office for Greenville County, and having a width of 70 feet and a depth of 194 feet; reference to said plat hereby pleaded for a more complete and accurate description.

Subject to all restrictions, easements, rights of way, roadways and zoning ordinances of record, on the recorded plats or on the premises.
