THIS MORTGAGE made this 28th day of November, 19 78,
among John D. Griffin (hereinafter referred to as Mortgagor) and FIRST
UNION MORTGAGE CORPORATION, a North Carolina Corporation (hereinafter referred to as Mortgagee):

WITNESSETH THAT, WHEREAS, Mortgagor is indebted to Mortgagee for money loaned for which
Mortgagor has executed and delivered to Mortgagee a Note of even date herewith in the principal sum of
Four Thousand and NO/100 (\$ 4,000.00), the final payment of which
is due on December 15 19 83, together with interest thereon as

hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys,
assigns and releases to Mortgagee, its successors and assigns, the following described premises located in
Greenville County, South Carolina:

ALL that certain piece, parcel or lot of land, with the improvements thereon, lying
being and situated in Austin Township, County of Greenville, State of South Carolina,
containing .72 acres, more or less, in accordance with plat made for John D. Griffin
by William R. McCoy and being more fully described in accordance with said plat,
to-wit:

BEGINNING at a cap in the center of Davenport Road at the southeastern property
corner of property of Edwin Griffin, et al, property and running thence along
the center of said Road, S. 57-10 W. 99.1 feet to bottle cap; thence S. 55-40 W.
