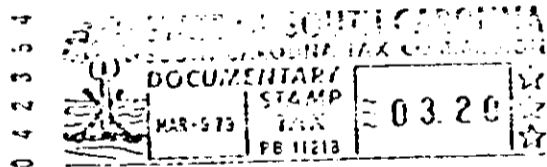
Dollars (\$8,000.00) due and payable according to the terms set forth in note dated March 9, 1979,
