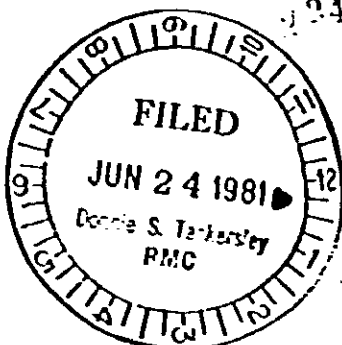
Four Thousand and 00/100 (\$4,000.00)-----DOLLARS,
