### MORTGAGE

THIS MORTGAGE is made this 27th day of April, 1981, between the Mortgagor, Sandra Chandler Turner also known as Sandra Chandler, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville shown as Lot 46 on plat of Oakfern, Section two, recorded in Plat book 6 II at page 53 and having such courses and distances as will appear by reference to said plat.

This being the same property conveyed to the mortgagor by deed of Edward H. Herbree Builders, Inc. and recorded in the RMC office for Greenville county on September 12, 1980 in Deed book 1133 at page 211.

This is second mortgage, and is Junior in Lien to that mortgage executed by Sandra Chandler Turner also known as Sandra Turner which mortgage is recorded in RMC office for Greenville County in book 1519 at page 590, recorded Sept. 12, 1980.
