THIS MORTGAGE is made this 6th day of October 1981, between the Mortgagor, T. Walter Brasher (herein "Borrower"), and the Mortgagee, AMERICAN FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of SOUTH CAROLINA, whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Thirty-Three Thousand Nine Hundred Fifty and No/100 Dollars, which indebtedness is evidenced by Borrower's note dated October 6, 1981 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on October 1, 2011.

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, at the southeastern corner of the intersection of Bransfield Road and Gavin's Point Road and being known and designated as Lot No. 396 of DEL NORTE ESTATES, Section V, plat of which is recorded in the REC Office for Greenville County in Plat Book 4-R at Page 17, and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.
